




1 April-May

Income tax return filing (FY 24-25)

>> Income tax return filing for FY 2023-24 for individuals and entities not liable for tax audit, and who have not entered into any international or specified domestic transaction.

Second advance tax instalment (FY 24-25)

>> 45% of the total estimated tax needs to be paid as advance tax instalment (after deducting the advance tax paid in previous instalments).

15th

Third advance tax instalment (FY 24-25)

- >> 75% of the estimated tax needs to be paid as advance tax instalment (calculated after deducting the advance tax paid in previous instalments)

31st

Belated return or Revised return (FY 24-25)

>>The due date for filing a belated or revised return.


